## Open Access: a strategic goal



Strategic aim 2.2: Our research quality and intensity is strengthened and the new knowledge we generate has maximum impact.

#### We will achieve this by:

- undertaking high-quality collaborative research activity with leading academic, business, government and third sector partners, underpinned by our commitment to useful learning
- enhancing the quality of our research outputs and adopting an informed publication strategy
- prioritising efforts and pursuing appropriate strategies to engage audiences with our research and to improve our performance in key citation metrics
- ensuring our research and knowledge reaches the widest possible audience, delivers reputational benefits, fulfils our commitment to support research integrity, and clearly demonstrates the quality and value of our research to potential partners and funders
- progressing towards fully open access publishing and fair open data policies

## Open Access: Why?





### Open Access: How?



- Green OA: author publishes in journal and deposits copy in repository (e.g. Strathprints via Pure)
  - Free!
  - Benefits from repository infrastructure
- Gold OA: author makes their article OA in a journal, for a fee
  - "article processing charge" (APC) -
  - UK average APC £2,000, but can vary greatly!





- Version of manuscript to be deposited in PURE is full-text accepted author manuscript (AAM) – within three months of manuscript acceptance
- Subsequent requirement for date of manuscript acceptance
- Journal articles and conference papers a "minimum requirement"
- Policy began on 01 April 2016
- Applies to everyone, whether funded or not







#### Gold OA



- Immediate Open Access
  - Via Gold OA journals (no 'hybrid')
- Funding for Open Access publishing fees available from different research funders:
  - UKRI (e.g. EPSRC, BBSRC, AHRC, etc.)
  - Cancer Research UK; British Heart Foundation
- Institutional Open Access Fund (IOAF)
  - Small University fund for 'unfunded' manuscripts (i.e. not funded by UKRI/RCUK or any of the biomedical charities above)





- Must be published with a CC-BY licence
- Must acknowledge funder including funder name and grant number
- Dataset acknowledgement, if applicable, <u>MUST</u> be included
  - Data need not be open; but must be accessible

## New workflows for ensuring Gold OA – Read & Publish deals



- Strathclyde is joining an increasing number of [blanket] R&P deals with publishers eg Springer, IOP, Wiley, Sage, Taylor&Francis, OUP, CUP...
- Particularly useful for 'unfunded' manuscript that would not be usually eligible for APC funding
